

Depending on the area you work in, Adagp can manage all or some of your royalties.

To become a member of Adagp, you must be an artist who has created a work of graphic or plastic art or an heir, beneficiary or assignee of a copyright in visual artworks.

You must check what documents are required and send them to us along with the completed application form which can be downloaded from this page. Your membership is effective from receipt of all the documents requested. You will receive a confirmation email with your membership number followed by a membership card which will be posted to you.

Adagp handles the royalties for all your works but does not get involved in contracts you signed prior to signing up for this service or, obviously, when you sell your work to a gallery, private individual or museum.

1. WHETHER YOU'RE AN ARTIST, BENEFICIARY OR ASSIGNEE, FIND OUT WHAT DOCUMENTS YOU NEED TO SEND US TO SIGN UP

If you are an artist

To sign up, simply post us the membership form available for download from this page, completed and signed, along with:

- copy of ID (identity card or passport)
- address of your website or documentation about your works (2 to 5 pages suffice, with details of your career or your exhibitions and a few images of your work)
- bank details
- a cheque for €15.24 (representing one share, payable to Adagp – payable once only. No annual contribution is due).

- And in particular for architects : the lists of the potential collaboration works and the sharing of the rights for the copyright holders of these works

If you are an heir or beneficiary

To handle the royalties of a deceased artist, we need a copy of the probate certificate, the order of succession or the certificate of inheritance, established on the death of the artist. If the heirs themselves are deceased, we also need to have officially recorded documents indicating the heirs of the deceased so we have all the succession documents.

To receive their share of royalties, each beneficiary must sign up to Adagp by returning the:

- the form available for download on this page duly completed and signed (2nd pink section:

“for completion by beneficiaries: heir, legatee, assignee”)

- the officially recorded documents mentioned above.

copy of ID (identity card or passport)

- address of artist’s website or documentation about his/her works (2 to 5 sheets suffice, with details of his/her career or his/her exhibitions and a few images of his/her works)

- bank details

- a cheque for €15.24 (representing one share, payable to Adagp – payable once only. No annual contribution is due).

If you are an assignee of copyright

For Adagp to handle the royalties, you must provide us with a copy of the assignment agreement and any information about the artist. If you are the assignee of only some of an artist’s works, you must also send us a list of the works concerned along with corresponding images.

To receive royalties, the assignee must sign up to Adagp by returning:

- the form available for download on this page duly completed and signed (2nd pink section: “for completion by beneficiaries: heir, legatee, assignee”)

- copy of the assignment agreement signed by the artist or his/her beneficiaries

- copy of ID (identity card or passport)

- address of artist’s website or documentation about his/her works (2 to 5 sheets suffice, with details of his/her career or his/her exhibitions and a few images of his/her works)

- list of works assigned and corresponding images

- bank details

- a cheque for €15.24 (representing one share, payable to Adagp – payable once only. No annual renewal).
